

The above numbered Request for Quotation (RFQ) is amended as set forth below. The hours and dates specified for receipt of responses remains unchanged.

This Amendment #3 provides responses to questions received the weeks of 8/17/15 and 8/24/15, as stated below.

**Inquiry 1 -**

Question 1: Will there be an invoice template available for establishing the institutional fixed price per case cost/payment schedule?

Response 1: The invoice template will be provided upon award; however, it is not to be used to establish the institution's fixed price per case. The payment schedule will be included in all contracts awarded as a result of the RFQ and will be based on the amount proposed per case.

Question 2: Do we derive our own fixed price per case based on the number of specimens we propose to collect?

Response 2: That is correct. This item would be subject to negotiation. **Per Section 7. To be Submitted with Offeror's Proposal:**

- The price per case of biospecimens, inclusive of all indirect costs;
- Supporting documentation for the price per case (i.e. commercial price list);
- For each cancer type (or sample) proposed, offeror should specify the approximate date (within 1 month) when the samples will be ready to be shipped to the BCR.
- A RFQ response page limit of 10 pages, inclusive of all/any attachments.

**Inquiry 2 -**

Question 1: The RFQ mentions the need for Snap Frozen samples and blood. Is there any need in the endeavor for OCT samples?

Response 1: OCT-embedded samples are acceptable for this solicitation; however, the samples must meet the other criteria specified in the Statement of Work.

**Inquiry 3 -**

Question 1: Can we negotiate for reporting on an every other month timeframe instead of every month?

Response 1: To clarify, there are NO monthly reports under these RFQs.
